## Tips for Writing a Successful Formula Prescription

- · Identify the appropriate formula and include its full name and flavor choice
  - Include "no formula substitutions" on script to ensure prescribed formula is provided
- Standard concentration for junior formulas is 30 kcal/oz. If concentrating at a different amount, please include the concentration
  - If not using standard concentration, provide mixing instructions\* to patient
  - Each 400 g pouch of formula provides approximately 62 fl oz of reconstituted formula when mixed to standard concentration
- · Include the amount of oz or ml per day
- Include route of administration (e.g. oral, NG-tube, G-tube, GJ-tube)
  - If tube feeding, provide tube feed instructions to patient
- Include ICD-10 codes for relevant diagnoses on the prescription (see chart below)
  - When appropriate, adding codes related to tube feeding, malnutrition, poor growth/FTT may be helpful in gaining insurance approval
  - It is often helpful to list the corresponding Z code where appropriate (see chart below)
- Include letter of medical necessity, clinical notes, growth charts and any other documentation that will support medical need
- Submit Rx and documentation to your preferred DME or CambrookeCare\*
- \* Your account rep can assist with DME suggestions, mixing guides, letter of medical necessity templates, and CambrookeCare forms.
